- Application for ST-ing in LiveText. Let Ms. Kusnierczyk (Kusnierczyk@cua.edu) and Dr. Agnes (nagyrado@cua.edu) know that you're planning to ST so that your name can be added to the database.
- Deadline for submitting ST-ing application. You MUST take (not necessarily pass) the PRAXIS II content (not pedagogy) test before student teaching.
- Continue using LiveText
- Key assessments in the junior year (lesson plans, thematic units, practicum evaluations, etc.)

PRAXIS Information

- **Elementary and secondary candidates need to take (not necessarily pass) content PRAXIS II test before student teaching. Check the ETS website for the appropriate content test. (Show candidates where info is on ETS website.) Please note that ECE candidates do not have a content PRAXIS II test requirement for license, so this rule only applies to ELE and SEC.**
- **NEW ECE PRAXIS II test!**
- In order to get a license, all ECE, ELE, (and SEC) candidates must pass (not only take) their PRAXIS II tests (both content and pedagogy). Please note that ECE candidates only have 1 test, but ECE candidates still need to take content ELE PRAXIS II to be highly qualified (#0014). In other words, ECE candidates only have 1 test for license, but to be highly qualified, they need to pass the ELE content PRAXIS II test (#0014).

Note:

- ETS must receive your completed registration form and payment by the appropriate date, or you will be charged a \$45 late fee.
- Not all test centers are open on all test dates. Please refer to the Test Center List page.
- You can get your scores by phone by calling 1-877-ETS-TEACH (\$20 per report). You will need to have your DOB, test date, and SSN for purposes of validation.
- **Make sure you mark CUA as one of the recipients of your scores because we need to report our graduates' performance for accreditation purposes.**
- **PRAXIS II is available *only* in paper-pencil format; computer-based versions are not available.** Please check deadlines for registration.

NOTE: It is possible to register for PRAXIS II as standby after the registration deadline. Those wishing to take the test as standby need to call ETS at 609-771-7395 one week before the scheduled time of the test.
